# Fishing Regulations – Etang de Revouire

## 5. Price of the Fishing Permit

Price in CHF	Adult	Child ( < 13 years)	Trout Quota in kg
Daily Permit (08:00 AM - 06:00 PM)	60.- CHF	free <sup>(1)</sup>	20 kg
Morning Permit (08:00 AM - 01:00 PM)	40.- CHF	free <sup>(1)</sup>	15 kg
Afternoon Permit (01:00 PM - 06:00 PM)	40.- CHF	free <sup>(1)</sup>	15 kg
Cantonal Tax (included in the permit) <i>it must be mentioned when taking out the permit if you hold a Valais cantonal fishing permit</i>	2.- CHF	free <sup>(1)</sup>	-

(1) Children must be accompanied by an adult with a valid fishing permit for the Étang de Revouire.

**A morning permit cannot be converted into a daily permit.**

**A fisherman can obtain a second permit if he reaches the authorized trout quota. However, he must do so immediately online at the website [www.giantfish.ch](http://www.giantfish.ch). In case of inspection and exceeding of the quota, a penalty of 50 CHF will be imposed, and the surplus of trout will be billed at 12 CHF per kilogram.**

## 6. Fishing Permissions

---

- 6.1 Fishing is allowed with only one rod and **one barbless hook**. Treble hooks are prohibited.

**Barb – Prohibited**



**Barbless**



**The offender will be prosecuted.**

- 6.2 **All natural or artificial baits are allowed**, as well as spoons, spinning lures, swimbaits, etc., **but with only one single barbless hook; treble hooks are prohibited.**

**Maggots and fish eggs are prohibited.**

- 6.3 **Any angler in possession of a valid fishing permit** can report the violations of other anglers to this regulation and report any problems to the controller, or by email with a supporting photo, to the address [info@gianttrout.ch](mailto:info@gianttrout.ch)

## 7. Obligations

---

- 7.1 **Fishing is only allowed from the border; fishing from a float tube, kayak, and small boat/rowboat is prohibited.**
- 7.2 **All fish that are allowed to be caught must be killed and bled. Catch and release is prohibited, as is keeping the fish alive in nets or traps. The fish must be caught by the mouth; spearfishing is prohibited!**
- 7.3 **Les prises de truites sont limitées à 20 kg pour le permis journalier et à 15 kg pour les demi-journées.**
- 7.4 Fishermen respect and help each other (fair play).
- 7.5 **Fishing from the south and north border is prohibited.**

## 8. Inspections and Penalties

---

- 8.1 **A security company**, mandated by the farmer, can check permits and monitor the pond. In case of irregularity, the offender will be reported to the hunting and fishing service and will be banned from the pond for two years. The offender also faces **a penalty of 1,000 CHF** to cover surveillance costs and to compensate for the damage caused; legal fees are the responsibility of the offender.
- 8.2 **The present regulations apply to fishing at the Étang de Revouire, and the fisherman accepts them unconditionally**
- 8.3 **Any modification of these regulations remains reserved to the farmer**
- 8.4 **In case of false declaration regarding the possession of the Valais cantonal permit, the farmer declines all responsibility and the fisherman is subject to a penalty from the hunting and fishing service**



## 9. Prohibitions

---

- 9.1 The use of a fish finder is not allowed.
- 9.2 It is prohibited to leave your waste (hooks, lines, thread, bait, etc.) around the pond.
- 9.3 It is prohibited to gut your fish around the pond and to throw the remains into the reeds or in the trash
- 9.4 Trespassing on the private property of residents and the cabin is prohibited.
- 9.5 It is prohibited to insult other fishermen and to disturb them (fair play).
- 9.6 Please park your vehicle only in the authorized areas and respect the signage put in place by the Commune of Grimisuat. In case of non-compliance, the farmer cannot be held responsible; the responsibility would then be entirely that of the fisherman/driver.

**All other Valais cantonal fishing directives apply to this regulation.**

Respect the environment in which you are fishing; it is always pleasant to find a clean place upon arrival and departure.

The stockings are regular and will be posted on social media.
