(1) Children must be accompanied by an adult with a valid fishing licence for Lago Mure.

A permit cannot be extended! The angler who wishes to continue fishing must obtain a new licence.

#### 6. Fishing Authorizations

- 6.1 All natural or artificial baits are allowed, including spoons, spinnerbaits, etc.
- 6.2 Fishing with maggots and fish eggs is prohibited.
- 6.3 Chumming is prohibited.
- 6.4 Any angler with a valid fishing permit can report violations of these rules by other anglers and report any problems to the controller.
- 6.5 Anyone caught fishing without a fishing permit will have to pay the full cost of a daily permit and a fine of 50.- EUR.
- 6.6It is forbidden to fish using only a landing net.
- 6.7 Entry is reserved only for anglers. Those who will be accompanied must inform the staff. Those who wish to enter to join relatives or friends must stop at the entrance and report their presence.
- 6.8 The vehicle must be parked in the parking lot on the left just after the barrier.
- 6.9 The path around the lake must not be obstructed by anglers' belongings; a vehicle should always be able to pass.
- 6.10 During fishing sessions, photos and videos will be taken and published on social media. Anyone who does not wish to be photographed must inform the staff.
  - 6.11 The fish allowed for fishing are: rainbow trout, brown trout, yellow/Japanese trout, and brook trout. Other species may be introduced for fishing but require the manager's approval, which will be communicated on social media.

#### 7. Obligations

- 7.1 Fishing is only allowed from the shore; fishing from a float-tube, kayak, and small boat is prohibited unless it is a special day or competition.
- 7.2 Maximum 2 treble hooks on artificial lures.
- 7.3 All fish allowed to be caught must be killed and bled. Catch and release is prohibited, as is keeping the fish alive in nets or cages. The fish must be caught by the mouth; spearing is prohibited! No-Kill is allowed provided the fish does not bleed and can be released.
- 7.4 Trout catches are unlimited.
- 7.5 Anglers respect and help each other (fair play).
- 7.6 **Adults accompanying minors** have the duty and responsibility to educate them in proper fishing.
- 7.7 At the end of the fishing session, it is mandatory to weigh the caught fish and return the fishing permit to check the end time (a tolerance of 15 minutes is allowed).

#### 8. Controls and Sanctions

- 8.1 A security company mandated by the manager can check permits and monitor the lake in case of irregularity. The offender will be fined 50.- EUR and must pay for a daily permit of 60.- EUR and will be banned from the lake for two years.
- 8.2 These regulations apply to fishing at Lago Mure and the angler unconditionally accepts them.
- 8.3 Any modification of these regulations remains the responsibility of the manager.

#### 9. Prohibitions

- 9.1 Fish finders are not allowed.
- 9.2It is forbidden to leave your waste (hooks, cigarette butts, lines, baits, etc.) around the lake.
- 9.3 It is forbidden to clean your fish around the lake and throw the remains in the lake or in the trash.
- 9.4It is forbidden to enter the private domain of residents and businesses in the private domain. All anglers and their companions must stay only around the lake.
- 9.5 It is forbidden to transfer the caught fish before the end of the fishing session and the weighing.
- 9.6 It is forbidden to insult or disturb other anglers (fair play).
